Passeport de rêve Air Canada 4th Edition Rules for the Draw Benefiting Opération Enfant Soleil

The Passeport de rêve Air Canada 4th Edition contest organized by Opération Enfant Soleil will begin on October 1st, 2022 and end on March 15th, 2023.

The holder of the first ticket drawn will receive one (1) prize, hereafter referred to as the “Grand Prize,” with a total value of \$104,000 and including:

- Eight (8) Business Class tickets valid for two years for any Air Canada destination, with an approximate commercial value of forty-four thousand Canadian dollars (\$44,000 CAN);
- One million five hundred thousand (1,500,000) Aeroplan miles, valued at forty-five thousand Canadian dollars (\$45,000 CAN), applicable according to the Aeroplan terms and conditions outlined at www.aeroplan.com;
- Fifteen thousand Canadian dollars (\$15,000 CAN) in cash, awarded in the form of a cheque made out to the winner when they claim their prize.

(Collectively, the “Air Canada Prize.”)

This prize is non-refundable, non-transferrable, and non-assignable.

The winner of the Grand Prize may choose between the prize valued at \$104,000 or the sum of \$25,000 CAN in cash.

The following conditions apply to the Grand Prize:

- a.** The winner and their companions must have valid passports prior to the departure date. The winner must take the steps to obtain their passport themselves.

- b.** Air Canada Prize winners and their travel companion are responsible for all fees, expenses and taxes not set forth herein, including and not limited to ground transportation, gratuities, merchandise, phone calls, personal expenses of any kind whatsoever for overnight stays, meals and beverages, management costs, meals and entertainment on board, travel expenses to and from the point of departure, as is where the Air Canada Prize begins and ends; the purchase, if necessary, of sufficient travel insurance, before departure; obtaining all necessary travel documents, such as passports and visas, proof of vaccination against COVID-19 and proof of negative screening test for COVID-19; compliance with entry, health, customs and immigration rules and requirements. - c.** In the event that the winner cannot accept their prize for any reason whatsoever (for example, if the winner does not hold a valid passport), they will receive no compensation in exchange, and they will not be able to transfer their prize to another person.

- d.** No changes are allowed for the reservations once the travel date is confirmed and the tickets have been issued. The trip booked with plane tickets must be completed by March 16th, 2025. No blackout period applies.

- e.** The Air Canada Prize must be accepted as is and can be used for products and services offered by Air Canada or its affiliated companies, as the case may be, in accordance with and subject to all relevant terms and conditions applicable at the time of exchange, including Air Canada's General Terms and Conditions of Carriage, accessible to the public at <https://www.aircanada.com/ca/en/aco/home/legal/conditions-carriage-tariffs.html>. Aeroplan points have no monetary value, but are redeemable according to the Aeroplan program for flights and other rewards. Aeroplan points can only be exchanged in accordance with the general terms and conditions of the Aeroplan program. - f.** A minimum of one (1) Aeroplan Miles exchange transaction per year is required to keep the miles account active. Besides this condition, the miles are valid until they are fully used.

- g.** The winner will be free to use the amount of \$15,000 CAN in cash that will be awarded to them by cheque however they wish—for example, on other trips.

- h.** The Air Canada Prize winner and their travel companion accept and acknowledge the risks associated with the spread of infectious or communicable diseases, and understand that it is the responsibility of the winners and their travel companion to take the necessary precautions in this regard, particularly in relation to COVID-19. The Air Canada Prize winner and their travel companion acknowledge having read the Air Canada CleanCare+ program and the mandatory health and safety measures then in effect. - i.** No Aeroplan points or miles or points from any other loyalty program will be awarded for travel. The use of eUpgrade Credits and Upgrade Bids is not permitted.

The organizers of the draw cannot be held liable:

- a.** In the event that one or more passengers are denied access to air transport by the carrier for any reason whatsoever. The same applies for entering another country or returning to Canada by either customs service. All passengers are responsible for complying with the laws and regulations of the countries visited, airports, airline, customs authorities, etc.;
- b.** In the event of a last-minute impediment, whether this is due to illness, accident, or any other unforeseen event whatsoever, the organizers cannot allow the prize to be transferred to another person;
- c.** In the event of any personal problem, illness, civil liability, or any other type of problem whatsoever, for the entire duration of the trip(s), the contest organizers cannot be held liable for any expenses relating to such inconveniences.

By participating in the draw:

- a.** Each eligible participant acknowledges and agrees that the Contest is in no way sponsored, endorsed, administered, or associated with Aeroplan, Air Canada, or any of its affiliated companies, and that Opération Enfant Soleil is fully responsible for running and administering the contest, especially selecting the winners and distributing the prizes;
- b.** Each eligible participant agrees to hold harmless and release Aeroplan, Air Canada, its subsidiaries and affiliated companies, as well as each of their officers, directors, employees, agents, representatives, subcontractors, and affiliated companies, from any liability for any claim or action, loss, fine, or legal fees arising directly or indirectly from the contest and its administration, the contest prizes, and related activities.

Secondary Prizes

Eight (8) secondary prizes will be drawn after the Grand Prize, and the holders of the winning tickets will each receive a prize according to the following order:

- The first (1st) winner will get a travel package to Italy "An Italian Dream!" » 7-nights/9-days package for two (2) people departing from Montréal-Trudeau International Airport, offered by Wingbuddy and valued at \$6,000, applicable according to the terms described at www.wingbuddy.com/forfait/5/un-reve-a-litalienne-montreal.
This package must be booked before October 31, 2023 to be valid.
- The second two (2) winners will each receive a \$2,500 gift card redeemable at Meubles Léon;
- The next five (5) winners will each receive a \$1,000 gift card redeemable at Flordeco.

These prizes are non-refundable, non-transferrable, non-assignable, and non-redeemable for cash. The gift cards and vacation packages must be redeemed at the respective stores and partners, according to the applicable terms and conditions of the issuer.

Under no circumstances may Opération Enfant Soleil be held liable for events following the taking of possession of the Grand Prize or the secondary prizes by the winners, including any modifications to the terms and conditions relating to the use of the Air Canada tickets, the exchange of the Aeroplan points, or the gift cards and vacation packages offered by the partners as secondary prizes, according to the terms and conditions stipulated by these partners.

Draws and claiming prizes:

The draw for the 4th edition of Air Canada's Dream Passport will take place on March 16, 2023 between 11 a.m. and 1 p.m. and will be held under the supervision of an auditor from Raymond Chabot Grant Thornton. For logistical reasons, the draw which was meant to be held at the Rythme FM studios located at 2830, boul. Saint-Martin East, Unit 100, Laval (Quebec) H7E 5A1, will be held at the head office of Operation Enfant Soleil, located at 450, Saint-Jean-Baptiste avenue, Unit 10, Quebec City, Quebec, G2E 6H5.

The draw will be recorded on video and published during the day on the Facebook page of Opération Enfant Soleil. All winners will be notified by phone within 48 hours and will be announced on the website www.passeportdereve.ca. All winners will be notified by telephone within the following 48 hours and will be revealed on the www.passeportdereve.ca website.

A total of 79,450 tickets are available. The 75,150 tickets sold at a cost of \$10 for a chance to win are numbered from 00,001 to 75,150. The 4,000 tickets sold at a cost of \$40 for 5 chances to win are numbered from 75,151 to 79,150, as well as the 300 tickets sold at a cost of \$100 for 15 chances to win are numbered from 79 151 to 79 450, will be available only online. The rights to distribute and sell all tickets for the draw are limited exclusively to persons authorized by Opération Enfant Soleil.

Single code ticket, purchased from our participating authorized partner

a. At an authorized participating partner, and for the duration of the sale of Air Canada Dream Passport tickets for the benefit of Opération Enfant Soleil at this partner, upon payment of the raffle ticket (\$10), you will receive a coupon (hereinafter referred to as "Coupon") confirming the purchase of the \$10 raffle ticket. On your Coupon, a unique code corresponding to the purchase of your ticket will be printed. The information on your Coupon will invite you to go to the Opération Enfant Soleil website at www.operationenfantsoleil.ca/comment-donne/tirages/passeport-de-reve/ to register your unique code and complete your participation in order to register, and to be assigned an electronic ticket, which will be sent to you by email at the end of your registration. You will have until February 28, 2023, 11:59 p.m. to register on the website as the holder of the Coupon in question. You will also be asked to sign your Coupon in the space provided for this purpose, as this constitutes proof that you are its owner and, therefore, owner of the lottery ticket associated with the unique code and which would have been declared a winner during the draw. You will also be asked to take a photo of your Coupon for your records. For any additional information or assistance, do not hesitate to contact Opération Enfant Soleil at the number printed on your Coupon.

b. For the draw, we will print a draw coupon with the lottery ticket number that has been assigned to your unique code, containing your information that you will have completed when registering on the website. This draw coupon will be deposited in the barrel, in the same way as all the other draw coupons. Following the draw, we will publish the list of winners of all prizes on the Opération Enfant Soleil website.

c. In the event that a purchaser of a unique code ticket has not completed his registration on the Opération Enfant Soleil website beforehand, the number of the lottery ticket paired with the unique code issued will be published in the list of winners. In this specific case, the Coupon signed by its owner will be required to claim its prize, within 30 days of the draw.

To participate, you must be 18 years of age or older, and to buy a ticket online, you must be a resident of Quebec. Opération Enfant Soleil employees and people living under the same roof cannot participate in the draw.

The winners must claim their prize by presenting their winning ticket and two (2) pieces of identification by April 15th, 2023 at the latest at the Opération Enfant Soleil head office, located at 450, avenue Saint-Jean-Baptiste, bureau 10, Québec City, Quebec, G2E 6H5 (telephone: 1-877-683-2325). In the event that any prizes remain unclaimed, Opération Enfant Soleil will carry out a second draw in the order of the initial draw at its head office on April 16th, 2023. The winners of this second wave of the draw will be contacted by telephone the same day. They will be able to claim their prize at the Opération Enfant Soleil head office located at 450, avenue Saint-Jean-Baptiste, bureau 10, Québec City, Quebec, G2E 6H5 (telephone: 1-877-683-2325) and will be revealed on the www.passeportdereve.ca website.

The winners agree, if required, and without compensation, that their name, photo, city of residence and/or any statement related to obtaining the prize, be used for publicity purposes relating to this draw.

Any conflict will be submitted to the Régie des alcools, des courses et des jeux, which will render a final decision.
